### Fees

The semen will be made available at **STRYDOM STUD** premises. Fees for transport and/or courier will be for the account for the mare owner. All cost per pertaining to the covering of the mare will be payable by the mare owner.

### **RIGHTS AND NOTICES**

#### Stallion Owner's Rights

- In the case of the mare being diagnosed barren for a valid reason, another mare can be used in the designated mare's place.
- If, for any reason, the stallion is unavailable to service the mare due to illness etc. then **Strydom Stud** will provide a breeding of similar value of an available stallion from the **Strydom Stud** can be chosen.
- If the mare does not provide a foal that is able to stand and nurse within twelve (12) hours of parturition, re-service by the stallion will be provided without the charge of additional covering fees, provided a licensed veterinarian attests to such an occurrence in writing and notifies **Strydom Stud** within one week of such an occurrence.
- A Covering Notice or Certificate will be provided to the mare's owner on the birth of a live foal provided that payment of all outstanding fees has been received.
- **Mare owner must inoculate against strangles and horse sickness.**
- **The visiting mare and foal must be dewormed and tick free on arrival.**

## Mare Owner's Rights

- To ensure that the mare is halter trained.
- To ensure that all relevant information regarding the mare is true and correct, providing copies of certificates etc.
- To notify **Strydom Stud** in the event of foal loss for whatever reason.
- To provide any other relevant information regarding the mare.
- All fees are to be paid in full before the owner collects the mare / mare and foal. **Strydom Stud** reserves the right to retain the mare owner's property until all fees are settled in full.
- **Strydom Stud** hereby agrees to issue a covering certificate on notification of the foal's birth.
- The Onderstepoort fees for verification of parentage are for the mare owner's account.

## DISCLAIMERS

### Attorney's Fees

Should there be a breach in this Agreement; the guilty party will be responsible for the attorney's fees involved.

### LIABILITIES

Should the visiting mare inflict damage on property or staff of **Strydom Stud**, the costs incurred will be debited to the visiting mare's owner.

Should injury occur to the visiting mare while on **Strydom Stud** premises, the owner is responsible for the full medical and stabling costs.

In the event of the stallion being sold, the covering will be transferred to the new owners or the outstanding covering fees paid by the buyers, will be refunded in full.

Should a "special covering offer" be available on a particular day and this "special" not fulfilled, then the mare owner will be eligible to swap this offer for another stallion of choice. The differential in price as at the special offer will be debited or credited to the mare owner's account. The values are calculated at the price of breeding at the time the swap is made.

**NOTICE**

This Agreement will not be valid unless completed in full, is non-transferable and is signed as complete without alteration.
